SURVEY OF THE CONTENTS OF THE COCKPIT AND CHISLEHURST REPORT, 1961 TO DATE

PREPARED BY ROY HOPPER

- The following is a survey of newsletters of The Chislehurst Society that we have in our archives. It was prepared by Roy Hopper, a member of the Executive Committee since December 1993, and Editor of The Cockpit since the edition of January 1996. He was formerly Branch Librarian at Chislehurst Library from July 1973 to 1990. Then, as a result of restructuring the service, he became one of a team managing seven smaller branches in the Borough of Bromley, including Chislehurst. Roy retired from the library service in May 1998.
- The newsletters themselves have been copied, and are available for review here.
- The first newsletter we have been able to identify was 'Chislehurst Resident. There appear to have been at least three editions. No 1 was published in December 1961, No 2 was distributed in January 1963, and No 3 in December 1964. We have been able to locate copies only of the first edition. The Cockpit was first produced in 1966, and served as the only newsletter of the Society for almost 30 years, covering current news, and increasingly including articles of historical interest. In 1994 Chislehurst Report was introduced to cover current affairs, leaving The Cockpit to focus on local history.

- In 1965 it was proposed that another edition of their magazine should be published. The idea, together with new name, The Cockpit – the journal of the Chislehurst Residents' Association, was part of a fresh drive for increased membership. Talking about the proposed new magazine, Mr F Grundy, who suggested the name, said he felt that in view of the change in Local Government, it was more than ever essential that the Ratepayer had an adequate representation on their Association in order that their voice might be more effectively heard

The Cockpit No 4 February 1968

The Cockpit No 5 November 1968

- Town's Meeting at Methodist Church Hall: Friday 25 November to discuss various matters
- Leasons/St Paul's Cray Roundabout: A large roundabout was envisaged which '*would swallow nearly an acre of common land*' with alarming possibility of road being widened to four lanes, '*a speedway cutting both commons into two halves*'
- September floods: Problems in Lower Camden, 14-15 September; Mentions 'fall of cliff at Lower Camden over a former entrance to the Caves' and part of footpath known as Kangaroo Walk was carried away; this was at the quarry behind Willett's stables and the small chalk mine in it, that features in Chelsea Speleological Society Records, vol XI [part 4] pp 3-6 with diagrams on p 4, contains account by Tony Turner of these events. This had no connection at all with main Caves

- Registration of Common Land: Mentions special meeting with Conservators – full agreement reached on boundaries to be registered at Cricket Ground Road, Verges in High Street and Royal Parade, which Committee claim to be Common Land, to be registered, (though not coming under jurisdiction of Commons Conservators)

- Sheppey as site of airport: Supporting speech against by MP Macdonald
- London Ambulance Service: 3 ½ hours to collect and return man needing 5 minutes treatment at Queen Mary's Hospital

- May Queen: Appeal for young male members of CRA to help preparation of arena on 3 May this year

The Cockpit No 8 November 1969

- Water Tower Seat: Details of donations list and appeal for support
- Public lectures by T.A.Bushell: "Old Chislehurst" (in black and white) at Village Hall on 26 November, and 'Chislehurst old and new, in colour' at Library, 2 December.
- May Queen: Brief account of event on 3 May
- Road safety: Continued attempts for controlled crossing at foot of Summer Hill
- Federation of Ravensbourne Residents' Association: Representative Alex Drage
- Bromley Consumers' Group and Civic Planning Association: CRA affiliates to both
- Chislehurst Public Library: Long debates on proposed repairs and extension; majority of committee felt £21k unjustified; Town Clerk said why it was needed in a letter; extended canvass of members found most in favour of extension
- Marlings Park Property Owners Association; Wound up during the year; balance of funds, £30 given to CRA and 97 members admitted as members of CRA
- Chislehurst Water Tower; with drawings of F Snocken's design and some history, including ironic reference to Sidcup Councillors wishing for a double decker bus to Bromley and still waiting for it

- Notice of AGM; and agenda on 26 February
 - Committee's report: refers to issues 7 & 8 of this newsletter, having given full reports of work up to November 1969, so issue 9 gives a summary [with useful financial details in re: water tower seat, finance and subscriptions]
 - List of road stewards with addresses
 - Balance sheet of CRA, May Queen Joint Committee and Chislehurst Water Tower Commemorative seat Appeal Fund (£86.13.6)

The Cockpit No 10 March 1970

- AGM: Report on 26 February – now possible to hold it in March or April – gives more time to prepare accounts – hope that better weather will give better turnout; Question of charges for use of car parks; vote to return to GMT in winter [nationwide debate on advisability of staying with Summer Time all year]
- Social Evening: Arranged for 16 April at Graham Chiesman House – Mayor and Mayoress, Chislehurst Aldermen and Councillors, Presidents of Chislehurst British Legion, Chamber of Trade and Rotary, Chairman of Board of Conservators, other leaders of civic life in Chislehurst invited
- May Queen: To be crowned 2 May [strong links still existed between MQ and CRA]

The Cockpit No 11 March 1971

- Notice of AGM: with agenda: Committee Report
- Social evening: 21 April: 1970 attendance 134
- May Queen

- Planning: Note of concerns at large size of proposed Art College in Walden Road, and demonstration with plans and model at October meeting

- Parish Church: proposed reordering at St Nicholas Church – useful details of proposals [which seem to me like desecration and positively Cromwellian]; CRA Committee members attended special meeting at Church, 12 July, to have possible changes explained; important point made that CRA is non-sectarian and cannot involve itself beyond architectural and historical aspects
- Ramblers' Rest: Access road made up by Brewer caused disturbance of minds
- Borough Conservation Area Consultative Committee: no definitive map yet agreed by GLC, but scheme good for Chislehurst
- Bromley and District Consumer Group: Affiliation to by CRA renewed
- Chislehurst Cricket Ground: Might be affected if rumours of amalgamated West Kent and Bromley Clubs occurs
- Water Tower Seat: Looks like happening due to £100 gift from Chislehurst Garden of Remembrance Association [now defunct]

 - Committee resignations: Colin Pilgrim, Mrs O Jarrett, V Leonard
